

Navigate to one of the following search functions

Enter search terms


Go to Header

Filter by field (option)

Select searched term in list

Open link in Detail Content




OPTION 2

Navigate to PROCESSES in list view

Click on magnifier icon

Search by content




OPTION 3

Set Scope filter(s) in Header


See appropriate processes

Detailing Roles is done in the Detail Content





STEP 4 Apply known roles

Responsible is always the last one releasing the process




STEP 3

Initiate release cycle


Go to Version dropdown in Toolbar of Main Content

Select 'Change state'



STEP 4


Check mandatory fields



STEP 5

Release process

In case a Quality Manager is set, the state first changes into "Ready for QA"

Highlight process flow objects that should be modified



STEP 4


Modify process flow

Copy/move selected objects (Feature only available after activation)

Delete selected objects

Add further objects

Swap paths for better layout




STEP 5

Create favorite/link

Define a favorite or subscribe to process to be informed by mail in case of changes

Create a link to share process with other users





Define further object architectures for DOCUMENTS, RISKS, REQUIREMENTS etc.




STEP 4

Define listed objects

Create further objects in a list like roles, locations etc.

Consolidate objects if they are redundant

Go back to Toolbar




STEP 3

Mark task to localize a single element OR

Localize entire process flow





STEP 4

Delocalize

Go to 'Localization reasons' in Detail Content

Click button to delocalize task or process





STEP 5

Update variant

Update only if Master has been changed

Localized element or process flow remain unchanged



If no filters are set, process or object are displayed in any query




Non-applicable processes are greyed out




STEP 4: Option 1

Set up stereotypes

Go to 'Localization reasons' in Detail Content

Click button to delocalize task or process





STEP 4: Option 2

Set task type/marker

Go to Detail Content

Choose task type and/or task marker from dropdown

See BPMN2.0 icon on task (only available after feature activation)


STEP 2 Select process

Use 'Permissions' in Toolbar to assign a specific permission set to a selected process

Also apply for categories or objects if required




STEP 3 Permit user groups




STEP 4 Set permission mode

Choose option whether permissions may be inherited from parent process (or not)

Decide whether permission is exclusive or whether standard set remains unchanged



STEP 5 Verify permissions



Create a Customer experience management (CEM) consisting of Customer journey maps below

Work out CJM


Design a Customer journey map (CJM) with the help of dropdown objects



STEP 4


Add information
